- Set up a new department and team for Business Development responsible for developing a marketing plan for the hospital and for 'next city' entry plan.
- Structuring the marketing activities with clear deliverables and OP growth targets. Our OP numbers are now averaging 200 daily.
- Taking up the project team, previously set up my predecessor Fellow, Charlotte, and completing and commissioning 3 major projects viz, CEH Main Hospital expansion, CEH Nyeri hospital and the first Vision centre (Clinic) in a satellite town (Ngong).
- Successfully trained all staff (152), filed and got approvals for the Data Protection policy under the DPA, Kenya. I continue to lead this process as the Data Protection Officer for the organisation, training new staff, re-training existing staff and liaising with CEH partners on data protection protocols.
- Leading the team in process audits and improvements of patient waiting times to at most 180 minutes for 90% of our daily patients.
